In keeping with the guidelines established February 2006 by the International Committee of Medical Journal Editors (*Uniform Requirements for Manuscripts Submitted to Biomedical Journals*), *IMCJ* requests the following:

Informed Consent/Coauthors

• Within the manuscript, authors should identify individuals who provide writing assistance and disclose the funding source for this assistance.

Informed Consent/Study Participants

- 1. Authors should not include identifying patient information—including patients' names, initials, or hospital numbers—in written descriptions, photographs, and pedigrees unless the information is essential for scientific purposes and the patient (or parent or guardian) gives written, informed consent for publication.
- 2. Complete anonymity is difficult to achieve, however, and informed consent should be obtained if there is any doubt. For example, masking the eye region in photographs of patients is inadequate protection of anonymity.
- 3. When informed consent has been obtained, it should be indicated in the published article and *a copy of the Patient Informed Consent Form for each patient should be included with article submission*. (See page 2 for a copy of the Patient Informed Consent Form.)
- 4. Authors should provide written verification that any study participants who are identifiable have been shown the **final** manuscript to be published. (This verification is included in the Patient Informed Consent Form on page 2.)

Masked Study Participants

• If identifying characteristics are altered to protect anonymity, such as in genetic pedigrees, authors should provide written assurance to the editors that alterations do not distort scientific meaning.
